Advertisement for Bids

NOTICE

Sealed bid proposals will be received by the Unity Township Municipal Authority, Unity Township Municipal Authority Building, 370 Pleasant Unity Mutual Road, Greensburg Pennsylvania 15601 until March 9, 2026, at 10:00 a.m. EST for the furnishing of process chemicals for pump stations and wastewater treatment facilities. Specifications can be obtained by contacting the Unity Township Municipal Authority at 724-423-6888.

Bids are to be submitted in a sealed envelope plainly marked "PROPOSAL – 2026 PROCESS CHEMICALS," March 9, 2026.

The Unity Township Municipal Authority reserves the right to reject any and all bids or to accept any bid or parts thereof which it deems necessary.

A certified check or bid bond drawn to the order of the Unity Township Municipal Authority, executed by the bidder and a surety company satisfactory to the Authority in an amount equal to not less than ten percent (10%) of the amount of the bid must be submitted with the proposal as bid security.

No bidder may withdraw his bid within sixty (60) days after the actual date of opening.

SPECIFICATIONS FOR PROCESS CHEMICALS

1) **GENERAL**

The process chemicals to be supplied under written quote are listed below in their approximate annual quantities:

<u>Process Chemical</u>	<u>Approximate Annual Quantity</u>	<u>Unit</u>
(20%) Caustic Soda	13,000	Gallons
(37% - 42%) Ferric Chloride	10,000	Gallons
(15%) Sodium Hypochloride	500	Gallons
(99.8%) Soda Ash Briquettes (50 lb Bags)	1,000	Pounds
(65%) Calcium Hypochloride (100 lb Containers)	400	Pounds

Delivery shall be within 10 days from the time of placing order. Chemical must be delivered by the vendor to various facilities located with-in Unity Township Municipal Authority's (UTMA) service area in the quantities required for that facility at various times throughout the year.

Quotes must be firm for the period of April 1, 2026 to March 31, 2027 and submitted on Quote Form provided. Unity Township Municipal Authority reserves the right to accept any particular chemical from your quote.

2) **20% CAUSTIC SODA**

Approximately 13,000 gallons of caustic soda in liquid form shall be delivered to the Pleasant Unity and 14 Mile Run Wastewater Treatment Plants in minimum quantities of 330 gallons.

The caustic soda supplied shall contain twenty percent (20%) sodium hydroxide (NaOH). Quotes must provide a complete analysis of caustic soda. Quotes shall quote price per gallons.

All quotes must be firm for the period of April 1, 2026 to March 31, 2027.

3) **FERRIC CHLORIDE**

Approximately 10,000 gallons of ferric chloride in liquid form shall be delivered to the Pleasant Unity Wastewater Treatment Plant in minimum quantities of 330 gallons.

The ferric chloride supplied shall contain thirty-seven percent (37%) to forty-two percent (42%) ferric chloride. Quotes must provide a complete analysis of ferric chloride. Quotes shall quote price per gallon.

All quotes must be firm for the period of April 1, 2026 to March 31, 2027.

4) **SODIUM HYPOCHLORIDE**

Approximately 500 gallons of sodium hypochloride in liquid form shall be delivered to the Pleasant Unity and 14 Mile Run Wastewater Treatment Plants in minimum quantities of 55 gallon drums.

The sodium hypochloride supplied shall contain fifteen percent (15%) sodium hypochloride. Quotes must provide a complete analysis of the sodium hypochloride.

All quotes must be firm for the period of April 1, 2026 to March 31, 2027.

5) **SODA ASH BRIQUETTES**

Approximately 1,000 pounds of soda ash briquettes in 50 pound bags shall be delivered to the Pleasant Unity and 14 Mile Run Wastewater Treatment Plants.

The soda ash briquettes shall contain 99.8% by weight sodium carbonate.

Quotes must provide a complete analysis of soda ash briquettes.

All quotes must be firm for the period of April 1, 2026 to March 31, 2027.

6) **GRANULAR CALCIUM HYPOCHLORIDE**

Approximately 400 pounds of granular calcium hypochloride in 100 pound containers delivered to the Pleasant Unity and 14 Mile Run Wastewater Treatment Plants in minimum quantities of 100 pounds.

The granular calcium hypochloride supplied shall contain sixty-five percent (65%) calcium hypochloride. Quotes must provide a complete analysis of calcium hypochloride.

All quotes must be firm for the period of April 1, 2026 to March 31, 2027.

7) **DELIVERY**

Delivery of any of the process chemicals must be with-in 10 days from the time of order.

All quotes must be firm for the period of April 1, 2026 to March 31, 2027.
